

Water/Sewer/Stormwater Supervisor

The City of Marysville, Kansas seeks a dedicated and energetic professional to serve as the next Water/Sewer/Stormwater Supervisor (Utility Supervisor).

The Marysville Water/Sewer Department operates with eight (8) full-time employees, which are under the direction of the Utility Supervisor. Marysville is a growing community of 3,405 located at the intersection of Highway 36 and 77. Marysville is an hour north of Manhattan and an hour and a half south of Lincoln, NE.

The Utility Supervisor is hired by and serves under the direction of the City Administrator. The City of Marysville is a Mayor-Council-Administrator form of government with eight (8) Council Members from four wards and a mayor that is elected at-large. Water, Sewer, and Stormwater utilities are the only City-ran utilities. The Utility Supervisor is a non-exempt position.

Ideal Candidate

The ideal candidate will have proven experience in both the administrative/finance and supervisory/management areas, as well as extensive experience with municipal utilities. The Utility Supervisor is expected to provide a proactive and engaging leadership style that seeks continuous improvement and community engagement. The ideal candidate will have an appreciation for a small community and the challenges and benefits associated with government in a small community.

The Utility Supervisor will need to be accessible to the public and eager to collaborate and partner with other cities. The supervisor will be active within the community and will frequently interact with various groups and businesses within the community. The supervisor is expected to have excellent written and verbal communication skills and be willing to communicate with staff and the community in an open and experienced manner.

Job Requirements

Experience: Three years related experience and/or training required. Appropriate water/wastewater operator certification is required within time frame established by state regulations.

Certification: KDHE Water/Wastewater Operator Certification

Education: High school diploma or general education degree (GED). Associate's degree or equivalent from two-year college or technical school is preferred.

Driver's License: Must possess a valid driver's license issued by the State of Kansas or eligible to obtain one within six months of appointment. Requires a valid Kansas Class B Commercial Driver's License.

Residency: There are no residency requirements for this position.

Background: Successfully complete a personal, financial, employment, academic and criminal background check.

Salary and Benefits

The pay range is \$21.35-36.51/hour. The starting salary is negotiable, based on qualifications. The position is non-exempt by FLSA. In addition to salary, The City of Marysville offers a competitive benefits package, including up to 100% paid for single health care, dental, and life insurance and 85% family health care. Family dental and life insurance are available as well. This position participates in Kansas Public Employees Retirement System.
